Dear Parents/ Guardians,

**P3 SWIMSAFER 2.0 PROGRAMME 2024 (3A, 3C, 3D & 3E)**

1. The school will be conducting the SwimSafer 2.0 Programme for P3 students in 2024. It is an opt-in programme. The objective of this programme is to develop students in important life skills such as water confidence and water safety.
2. The SwimSafer Programme consists of six progressive stages that are conducted by qualified swimming instructors. Survival and activity skills will be taught at each stage of the programme. 3. The details of the programme are as follows:

4. Teachers will accompany their respective classes to the swimming complex.
  - a. Students will be given time to change and get ready from 12.00 p.m. to 12.30 p.m. before boarding a bus to the swimming complex for their swimming lessons.
  - b. After the swimming lesson, students will board a bus back and be dismissed from school at about 3.20 p.m.
  - c. Please make the necessary transport arrangement for your child/ward if he/ she is participating in the programme.
5. The programme fee is fully funded by the school.

6. Students will change into their swimming trunks/ costumes and wear their school P.E. attire over it before boarding the bus to the swimming complex. After the swimming lesson, students will have a quick rinse and change back into their P.E. attire at the swimming pool.
7. **Please help to ensure that your child/ ward packs the following items in a small bag for every swimming lesson. You may like to label your child's/ ward's belongings with his/ her name and class using a permanent marker.**
  - a. Swimming trunks/costume
  - b. Goggles
  - c. Towel
  - d. Water bottle
  - e. Raincoat/poncho
  - f. Inhaler (for students with asthma)
  - g. Sunblock lotion/cream
  - h. Slippers
  - i. A plastic bag (to contain the wet items after the swimming lesson)
8. For the safety of every student, we seek your partnership in reinforcing the following safety precautions with your child/ ward:
  - a. Students should wear proper swimming trunks/costumes.
  - b. Listen and follow instructions from swimming instructors and teachers.
  - c. No student should leave the pool without permission.
  - d. Running alongside the pool deck is not allowed.
  - e. Pushing friends into the pool is not allowed.
  - f. Students are not allowed in the water until permission is granted by the swimming instructors.
  - g. Students should not swim if they have any foot or skin infection.
  - h. Students should not swim if they are unwell.
9. For the school to make the necessary arrangements, we would appreciate it if you could indicate your consent via Parents Gateway or return the attached Reply Form duly completed to your child's/ ward's Form Teacher **by Tuesday, 21 November 2023**.
