## Safe Management Measures for Condominiums in Phase 2 (Heightened Alert) [From 22 July 2021 Onwards]

The Multi-Ministry Taskforce had announced on 20 July 2021, further tightening of the safe management measures in Phase 2 (Heightened Alert), starting from 22 July 2021.

2 Management Corporations (MCSTs) should note the following safe management measures (SMMs) and put in place measures to ensure compliance with these SMMs by their residents.
