A) Streamlining Antigen Rapid Test (ART) Regime at Worksites

BCA has worked with the construction sector and piloted ART at more than 50 worksites since 31 May 2021. A total of about 7,000 tests have been successfully administered at these sites. With data and feedback collected from the sites, and engagement with the various pilot sites' representatives, BCA will be streamlining the ART regime at worksites. The revised streamlined regime will take effect from 8 July 2021. Please refer to Infographic A below for more information on the revised regime:
