## FOREWORD

---

### **Majlis Ugama Islam Singapura**

Majlis Ugama Islam Singapura (Muis), also known as the 'Islamic Religious Council of Singapore', was established in 1968 pursuant to the enactment of the Administration of Muslim Law Act. Muis is a statutory board under the Ministry of Culture, Community and Youth and administers Muslim affairs in Singapore. Among others, Muis issues Halal certificates and regulates the Singapore Halal industry. More information on Muis' roles and responsibilities is available at [www.muis.gov.sg](http://www.muis.gov.sg).

### **Administration of Muslim Law Act**

88A – (1) The Majlis may issue halal certificates in relation to any product, service or activity and regulate the holders of such certificates to ensure that the requirements of the Muslim law are complied with in the production, processing, marketing or display of that product, the provision of that service or the carrying out of that activity.

(2) An application for a halal certificate shall be in such a form as the Majlis may require.

(3) The Majlis may, in issuing a halal certificate, impose such condition as it thinks fit and may at any time vary, remove or add to such condition.

(4) The Majlis may, by notification in the Gazette, specify any certification mark of the Majlis for use in relation to any product, service or activity in respect of which it has issued a halal certificate under subsection (1).

(5) Any person who, without the approval of the Majlis:

- (a) issues a Halal certificate in relation to any product, service or activity; or
- (b) uses any specified Halal certification mark or any colourable imitation thereof,

shall be guilty of an offence and shall be liable on conviction to a fine not exceeding \$10,000 or to imprisonment for a term not exceeding 12 months or both.

(6) The Majlis may, in granting approval to any person to issue any Halal certificate or to use any specified Halal certification mark, impose such condition as it thinks fit and may at any time vary, remove or add to such condition.

(7) The Majlis may revoke or suspend its approval granted to any person to issue any Halal certificate or to use any specified Halal certification mark if that person fails to comply with any condition imposed under subsection (6).

(8) Any person aggrieved by any decision of the Majlis made under this section may appeal to the Minister whose decision shall be final.

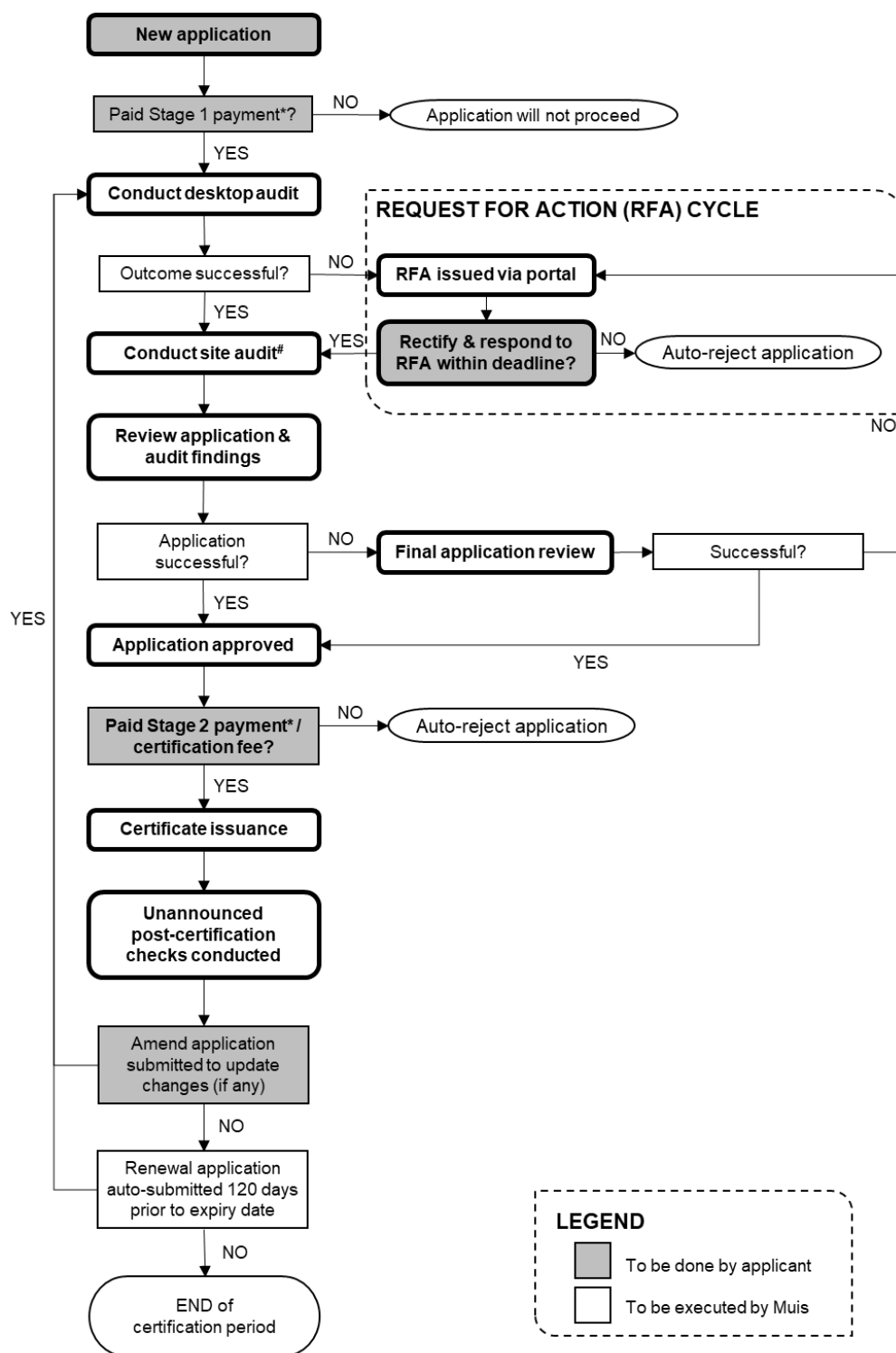

## HALAL CERTIFICATION CONDITIONS

<b>1. GENERAL INFORMATION</b>		
1.1	The conditions set out in this document shall hereinafter be referred to as the “Muis Halal Certification Conditions”. All annexes to these Muis Halal Certification Conditions shall be deemed to be incorporated in and form an integral part hereof. Words or phrases in these Muis Halal Certification Conditions that are defined in Annex C – Glossary shall bear their defined meaning unless the context otherwise requires.	<b>Muis Halal Certification Conditions</b>
1.2	<p>All companies / establishments applying for a Halal certification from Majlis Ugama Islam Singapura (Muis), may, upon fully complying with the Muis Halal Certification Conditions, be issued a Muis Halal certificate (the “Halal certificate”) and allowed the use of Muis Halal certification mark (the “Halal certification mark”) upon the terms and subject to the conditions provided therein.</p> <p>Applicants are encouraged to apply for Health Promotion Board (HPB)’s Healthier Dining Programme (HDP)<sup>1</sup>. HDP aims to assist food and beverage businesses to provide healthier food and drinks options to their customers. 1.3	The applicant is deemed to have agreed to share its company’s information to Muis upon submitting an application to Muis.	<b>Agreement by applicant</b>
1.4	All information submitted by the applicant will not be disclosed to any other person except for the purpose of determining the outcome of this application.	<b>Confidentiality of application</b>
1.5	<p>The applicant shall ensure personnel representing the company / establishment (including the applicant):</p> <ul style="list-style-type: none"> <li>(a) does not use any indecent, threatening, abusive or insulting words or behaviour in communication with Muis;</li> <li>(b) does not collect, use or disclose personal data (which includes photographs, video and audio recordings) of Muis officers unless consent is given.</li> </ul>	<b>Protection for Muis officers</b>



1.6	<p>The Eating Establishment scheme (Category 1) in this document shall be applicable to the operation of the following types of retail food establishments in Singapore:</p> <ul style="list-style-type: none"> <li>(a) Hawker Stalls;</li> <li>(b) Snack bars / Bakeries;</li> <li>(c) School Canteen Stalls;</li> <li>(d) Short-term Stalls.</li> </ul> <p>Note: For outlets (franchise / chain) and establishments with central kitchen, they will fall under <b>Eating Establishment scheme (Category 2)</b>, regardless of the type of establishments they comprise.</p>	<b>Types of businesses under Eating Establishment scheme (Category 1)</b>
1.7	<p>The scope of certification shall include:</p> <ul style="list-style-type: none"> <li>(a) Receiving, storage and handling of ingredients and prepared food;</li> <li>(b) Areas of storage, preparation, dishing, display and serving area of food and drinks;</li> <li>(c) Collection, handling, washing and storage of equipment and utensils;</li> <li>(d) Packaging of food for takeaway.</li> </ul>	<b>Scope of certification</b>
<b>2. APPLICATION REQUIREMENTS</b>		
2.1	The applicant shall read, understand and agree to adhere to the Muis Halal Certification Conditions upon submission of the application.	<b>Compliance at all times</b>
2.2	Any request for waiver of the Muis Halal Certification Conditions shall be submitted in writing using the form provided by Muis or provision via online application system.	<b>Request for waiver of Conditions</b>
2.3	<p>The applicant shall submit a New application if:</p> <ul style="list-style-type: none"> <li>(a) Its current outlet has not been previously Halal-certified by Muis;</li> <li>(b) It has a new outlet and its other chain or franchise outlet(s), bearing the same business name and/or branding, are already Halal-certified by Muis; <ul style="list-style-type: none"> <li>i. The application has to be done within 7 working days from the opening date of the new outlet;</li> <li>ii. If the previous application was rejected or cancelled, the new application shall be submitted within 7 working days from the date of rejection or cancellation.</li> </ul> </li> <li>(c) There is a change in: <ul style="list-style-type: none"> <li>i. Ownership / unique entity number (UEN) / name of business entity</li> <li>ii. Scheme or sub-scheme</li> <li>iii. Name and/or address of certified premises</li> </ul> </li> </ul>	<b>Submission of New application</b>

	<ul style="list-style-type: none"> <li>(d) Its Halal certificate has expired, and renewal application was not submitted when submission was due;</li> <li>(e) The renewal period for the existing Halal certificate has lapsed;</li> <li>(f) Its previously submitted application was rejected;</li> <li>(g) Its Halal certificate has been revoked.</li> </ul>	
2.4	<p>In addition to the Eating Establishment scheme, the applicant shall also apply for:</p> <ul style="list-style-type: none"> <li>(a) Food Preparation Area scheme if it is licensed to cater or distribute to other outlets under the Eating Establishment scheme;</li> <li>(b) Product / Whole Plant scheme if it provides prepacked food for retail sale;</li> <li>(c) Storage Facility scheme if its raw materials and processing aids are stored in a self-managed facility outside of the premises that is to be certified.</li> </ul>	<b>Application for multiple schemes</b>
2.5	<p>Application for Short-term Stall sub-scheme shall be submitted at least 5 working days before commencement of operations, in the event:</p> <ul style="list-style-type: none"> <li>(a) the operator is an existing Muis Halal certificate holder;</li> <li>(b) the short-term stall bears the name and/or branding of its Halal-certified premises; and</li> <li>(c) the short-term stall is operated at a location other than its certified premises for at least 7 consecutive days or more.</li> </ul>	<b>Application for Short term</b>
2.6	<p>The applicant may be advised to change the scheme and/or subject to additional requirements as Muis deems fit. Where the applicant has applied for waiver of the Muis Halal Certification Conditions, this may include additional imposed conditions that will accompany the Muis Halal Certification Conditions waivers granted to applicant (refer to Table A).</p>	<b>Additional requirements if necessary</b>
2.7	<p>The applicant shall take ownership and bear responsibility for its application at all times. The applicant shall communicate directly with Muis on all matters related to Halal Certification.</p>	<b>Ownership and responsibility</b>
<b>3. GENERAL CERTIFICATION REQUIREMENTS</b>		
3.1	<p>The applicant shall be adequately licensed by the competent food safety authority.</p>	<b>License by food safety authority</b>
3.2	<p>The scope of certification for the premises shall be identified and maintained as documented information (i.e. floor plan).</p> <p>This is applicable to all sub-schemes in this document <b>except for Hawker and School Canteen Stall sub-schemes.</b></p>	<b>Demarcation of scope of certification</b>

3.3	The applicant shall ensure that there is no cross-mixing of Halal and non-Halal food and ingredients.	<b>No cross-mixing</b>
3.4	<p>The applicant shall only order, purchase, receive, store, prepare, cook, offer to sell and sell Halal food and ingredients that have been declared to Muis.</p> <p>Declaration of ingredients and menu items shall be done during the application.</p> <p>Naming of menu items shall take into account cultural and religious sensitivities, and may be subject to change if Muis deems that the menu item name is inappropriate.</p> <p>Details of ingredients' declaration shall include:</p> <p><u>For meat and meat-based (including poultry) items</u></p> <ul style="list-style-type: none"> <li>(a) item name, <b>brand</b> and/or description</li> <li>(b) name of supplier (as reflected on invoice)</li> <li><b>(c) name of Halal certification body</b></li> </ul> <p><u>For all other items</u></p> <ul style="list-style-type: none"> <li>(a) item name and/or description</li> <li>(b) name of supplier (as reflected on invoice)</li> </ul>	<b>No undeclared and/or non-Halal items</b>
3.5	<p>All ingredients and food products prior to purchase shall be substantiated with <b>product specifications or labels</b>. In addition, ingredients and food products which are categorised as Medium-Low, Medium-High or High Halal risk will require additional documents for approval (refer to Annex A):</p> <ul style="list-style-type: none"> <li>(a) <u>Medium-Low</u> <ul style="list-style-type: none"> <li>- Muis general questionnaire (if necessary)</li> </ul> </li> <li>(b) <u>Medium-High</u> <ul style="list-style-type: none"> <li>- Muis general questionnaire;</li> <li>- Muis-recognised Halal certificate or laboratory analysis report by an accredited laboratory (if necessary)</li> </ul> </li> <li>(c) <u>High</u> <ul style="list-style-type: none"> <li>- Halal certificates from Muis and/or Muis-recognised Halal certification bodies.</li> </ul> </li> </ul>	<b>Need to be Halal and substantiated with relevant documents</b>

3.6	Halal certificates issued by Muis or Muis-recognised Halal certification bodies will no longer be valid if the certified item is repacked outside of the premises it was originally certified in.	<b>Invalidation of Halal certificate upon repacking</b>
3.7	<p>The applicant shall ensure that all ingredients are labelled in English, minimally with the following information for traceability purpose:</p> <ul style="list-style-type: none"> <li>(a) product name and description,</li> <li>(b) manufacturer/brand owner's name;</li> <li>(c) manufacturer/brand owner's address.</li> <li>(d) abattoir / plant number*;</li> <li>(e) Halal slaughtering and packing date*;</li> <li>(f) Halal mark or equivalent*.</li> </ul> <p>*Only for high-risk items such as imported meat / poultry.</p> <p>Muis may also consider alternative documents to determine the traceability of a Halal certificate / documents to an ingredient / raw material.</p>	<b>Proper labelling</b>
3.8	A laboratory analysis report according to Muis' requirements may be required by Muis to confirm that the products, raw materials, additives and/or processing aids are Halal. This may be during the initial audit and/or periodic inspections and/or renewal audit. The selection of the accredited laboratory and procedure for product sampling shall be decided by Muis. The applicant shall bear all costs of the laboratory testing.	<b>Laboratory analysis</b>
3.9	The applicant shall ensure that equipment and utensils used in the handling of Halal-approved food and ingredients do not come into contact with pork or its derivatives. In the event there is such contact, it shall be declared and subjected to ritual cleansing by Muis.	<b>Handling of food and ingredients</b>
3.10	<p>The applicant shall ensure that at least the Halal Team Leader and Halal Assurance Officer have valid Halal Competency Assessment (HCA) certificates by the end of stipulated 2-stage transition period.<sup>2</sup></p> <p><sup>2</sup> For more information on this transition period for competency requirement, applicants may refer to <a href="https://www.muis.gov.sg/Halal/Halal-Certification/Halal-Competency">https://www.muis.gov.sg/Halal/Halal-Certification/Halal-Competency</a>.</p>	<b>Competency Requirement</b>

3.11	<p>The applicant shall maintain the following documentations and records:</p> <ul style="list-style-type: none"> <li>(a) Licence issued by relevant food authority</li> <li>(b) Proof of Halal competency (i.e. Halal Competency Assessment certificate)</li> <li>(c) Proof of attendance for current Muslim personnel</li> <li>(d) List of menu items</li> <li>(e) List of ingredients, and their supporting documents</li> <li>(f) Past records of original invoices and delivery orders</li> <li>(g) Halal periodic inspection reports (if any)</li> <li>(h) Any other communications from Muis</li> </ul>	<b>Systems-related requirements</b>
3.12	The applicant shall engage at least 2 permanent Muslim personnel.	<b>Muslim personnel</b>
3.13	<p>The Muslim personnel shall:</p> <ul style="list-style-type: none"> <li>(a) advise the food business on Halal food matters as well as cultural and religious sensitivities relating to them;</li> <li>(b) assist in complying with the conditions stipulated in this document</li> <li>(c) endorse the original invoices and delivery orders mentioned in Clause 3.10(f) with – <ul style="list-style-type: none"> <li>i. his / her signature</li> <li>ii. his / her name</li> <li>iii. date of verification</li> </ul> </li> </ul>	<b>Responsibilities of Muslim personnel</b>
<b>4. SPECIAL CERTIFICATION REQUIREMENTS</b>		
4.1	<p>The applicant under Hawker sub-scheme shall comply with the following requirements:</p> <ul style="list-style-type: none"> <li>(a) Separate applications shall be submitted for individual stalls seeking Halal certification within the food court according to the name on the signboard and/or type of menu served, regardless of the operator.</li> <li>(b) All soiled utensils shall be collected separately.</li> <li>(c) There shall be dedicated and clearly demarcated washing point for soiled utensils.</li> <li>(d) Food sold shall not be labelled or advertised in a manner that is misleading or is likely to create an erroneous impression of the scope of any Halal certification awarded by Muis.</li> </ul>	<b>Additional Conditions for Hawker sub-scheme</b>
4.2	Notwithstanding Clause 3.5, the applicant under <b>Hawker and School Canteen Stall sub-scheme</b> may purchase ingredients from retail stores via physical or online means, subject to the conditions stipulated in Annex B.	<b>Purchasing from retail stores</b>

4.3	<p>The applicant under Snack Bar / Bakery sub-scheme shall comply with the following requirements:</p> <ul style="list-style-type: none"> <li>(a) All food and drinks sold at the snack bar shall be prepared within the snack bar.</li> <li>(b) The central kitchen that delivers semi and/or fully-processed foods and drinks to the Snack Bar / Bakery shall be Halal-certified under – <ul style="list-style-type: none"> <li>i. Food Preparation Area scheme if the kitchen is managed by the same company;</li> <li>ii. Product / Whole Plant scheme if the kitchen is managed by another company</li> </ul> </li> <li>(c) Food sold shall not be labelled or advertised in a manner that is misleading or is likely to create an erroneous impression of its Halal status.</li> </ul>	<b>Additional Conditions for Snack Bar / Bakery sub-scheme</b>
4.4	<p>Short-term Stall sub-scheme is applicable only for applicants with a valid Muis Halal certificate at the time of application submission. The applicant under Short-term Stall sub-scheme shall comply with the following additional requirements and subject to the process flow as indicated in Annex E:</p> <ul style="list-style-type: none"> <li>(a) All food and drinks sold at the short-term stall shall be prepared within the short-term stall.</li> <li>(b) All semi and/or fully-processed foods and drinks shall be delivered from an entity which is Halal-certified by Muis.</li> <li>(c) Halal certificate issued to a short-term stall holder is non-renewable.</li> </ul>	<b>Additional Conditions for Short-term Stall sub-scheme</b>
4.5	<p>Applicant may allow guide dogs accompanying a blind or visually-impaired customers to be brought into the certified premises as stipulated by Singapore Food Agency (SFA)<sup>2</sup>. Within the certified premises, the guide dog shall:</p> <ul style="list-style-type: none"> <li>(a) Be kept under proper control;</li> <li>(b) Be restrained from straying or causing annoyance or nuisance, or from damaging any property;</li> <li>(c) Be held in a leash;</li> <li>(d) Not be fed within the food establishment, unless it is a pet café; and</li> <li>(e) Not be petted by other diners.</li> </ul> <p><sup>2</sup> For more information, applicants may refer to <a href="https://www.sfa.gov.sg/food-retail/advisories-for-sfa-food-establishment-licenses/advisories-for-sfa-food-establishment-licenses">https://www.sfa.gov.sg/food-retail/advisories-for-sfa-food-establishment-licenses/advisories-for-sfa-food-establishment-licenses</a>.</p>	<b>Entry of guide dogs</b>

5.1	<p>The processing of application shall commence:</p> <ol style="list-style-type: none"> <li>1. <u>Within 14 working days</u> from the date of payment for New (normal) application;</li> <li>2. <u>Within 7 working days</u> from the date of payment for New (express)* application;</li> <li>3. <u>Within 14 working days</u> from the date of application submission for Amend application.</li> </ol> <p>If there are any outstanding dues from past applications, processing of new applications will be put on hold.</p> <p>* Note: Express application will grant priority for the <b>commencement</b> of the application processing. However, the overall processing time is subjected to the complexity of the application.</p>	Commencement of application processing
5.2	<p>Upon successful transaction of stage 1 payment, the applicant shall:</p> <ol style="list-style-type: none"> <li>(a) access the application portal regularly for information on application status and Request For Action notices. Email notifications will be sent to the applicant's email address indicated during application.</li> <li>(b) be prepared for a site audit by Muis after applicant has commenced operations. Repeat audits may be conducted, as and when necessary.</li> <li>(c) not make any Halal-related claims or advertisements that indicates he is applying, has applied or renewing for Halal certification for the related premises.</li> </ol>	Monitoring of application
5.3	<p>Muis shall, at its discretion, decide on the certification duration, type of scheme and other conditions for approval of the application.</p>	Discretion by Muis
5.4	<p><b>If there is additional payment required upon approval of application, payment shall be made within 30 working days from the date of payment advice. After payment has been received, the Halal certificate will be couriered out to the mailing address indicated in the application form. ## ANNEX C – GLOSSARY

<b>Administration of Muslim Law Act (AMLA)</b>	An Act relating to Muslims and to make provision for regulating Muslim religious affairs and to constitute a council to advise on matters relating to the Muslim religion in Singapore and a Syariah Court.
<b>Additive</b>	Substances added to food to preserve flavour or enhance its taste and/or appearance.
<b>Amend Application</b>	Application submitted via the application portal seeking approval for the changes to the previously approved Halal application.
<b>Applicant</b>	Company / Establishment submitting an application for the purpose of Halal certification which include personnel employed by the Company / Establishment.
<b>Central Kitchen</b>	Kitchen which prepares semi- / fully- processed items and transports to its retail outlets for further processing or use, prior to sale of the finished items or for sale as is condition.
<b>Chain Outlets</b>	More than one outlet bearing the same business name and/or management.
<b>Documentation</b>	Written proof of step-by-step process documenting a routine.
<b>Express Application</b>	Application processing shall be initiated within 7 working days upon submission of a New application and payment of the non-refundable application fees. It does not guarantee the issuance of a Halal certificate within 7 working days.
<b>Food</b>	Includes drinks.
<b>Franchise Outlets</b>	The right or license granted by a company to an individual / company to operate a business / establishment at a specific location using their name and system.
<b>Halal</b>	Means "Permissible".  Halal, in relation to any product, service or activity, means the requirements of the Muslim law are complied with in the production, processing, marketing, display or carrying out, as the case may be, of that product, service or activity.  Refer to the Singapore Muis Halal Standard on 'General Guidelines for the Handling and Processing of Halal Food' (MUIS-HC-S001) for more information.
<b>Halal Competency Assessment (HCA)</b>	HCA is an assessment to recognise individuals' Halal competency as part of the requirement for certification. Upon passing the HCA, the individual will be awarded with HCA certificate.

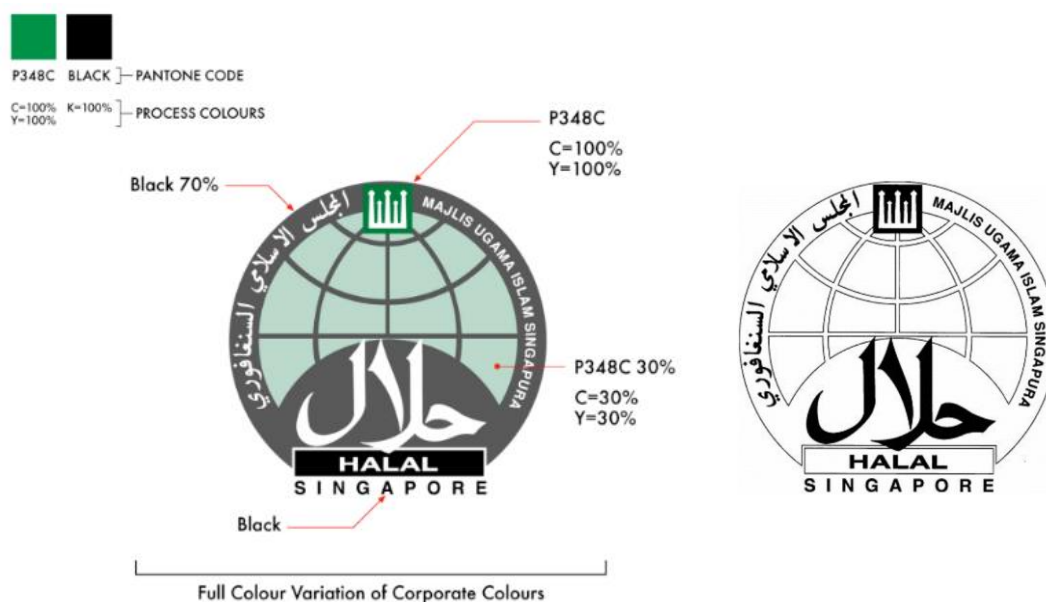
<b>Hawker Stall</b>	<p>Stall selling cooked or uncooked food. <b>Limited Time Offer (LTO)</b>	A special menu item or set of menu items available for a defined short period of time.

<b>Muis Halal Certificate</b>	A certificate issued by Muis under Section 88A of the Administration of Muslim Law Act (Cap 3). "Halal certificate", in relation to any product, service or activity, means a certificate to the effect that the requirements of the Muslim Law are complied with in the production, processing, marketing or display of that product, the provision of that service or the carrying out of that activity.
<b>Muis Halal Certification Mark</b>	Refers to any certification mark specified by Muis for use in relation to any product, service or activity in respect of which it has issued a Halal certificate under Section 88A (1) of the Administration of Muslim Law Act (Cap 3).
<b>Muslim</b>	A person who professes the religion of Islam in accordance with the Muslim Law.
<b>New Application</b>	Fresh application submitted for the purpose of Halal certification.
<b>Non-Halal</b>	<p>Means "not permissible".</p> <p>Non-halal, in relation to any product, service or activity, means the requirements of the Muslim law are not complied with in the production, processing, marketing, display or carrying out, as the case may be, of that product, service or activity.</p> <p><b>For the purpose of Halal certification, food and ingredients which are not supported with the relevant documents as shown in Annex A will be regarded as non-Halal.</b></p>
<b>Normal Application</b>	Application processing shall be initiated within 14 working days upon submission of a New application and payment of the non-refundable application fees. It does not guarantee the issuance of a Halal certificate within 14 working days.
<b>Permanent Muslim Personnel</b>	Staff of a company / establishment who is a Muslim and employed on a full-and/or part-time permanent basis. It includes the owner of a company / establishment who is a Muslim.

<b>Prepacked Food</b>	<p>Food that is packed in advance for sale in a wrapper or container, and bears a label containing all the particulars required by food regulations stated in Sale of Food Act (Chapter 283, section 56(1)) (i.e. for sale to consumers).</p> <p>Food packed in non-retail containers (i.e. for supply to food manufacturers or food services for further use) is not considered as prepacked food.</p>
<b>Processing Aid</b>	Any substance or material, not including apparatus or utensils, and not consumed as a food ingredient by itself, intentionally used in the processing of raw materials, foods or its ingredients, to fulfil a certain technological purpose during treatment or processing.
<b>Product</b>	Refers to any food and non-food substance or material, which may be unprocessed, semi-processed or fully-processed, that may be bought, used, manufactured and/or distributed by a company / establishment. Refers also to the stock-keeping unit.
<b>Raw Material</b>	Crude or processed material that can be converted by manufacture, processing or combination into a new and useful product.
<b>Renewal Application</b>	Application auto-submitted to renew the status of the existing Halal certificate 120 days prior to its expiry.
<b>Request For Action (RFA)</b>	Non-compliance with the Muis Halal Certification Conditions that shall be addressed within the agreed deadline between Muis and applicant.
<b>Retail Sale</b>	A retail sale occurs when a business sells the product directly to consumers for his or her own use (including brick-and-mortar shops such as supermarkets, minimarts, and online platforms).
<b>School Canteen Stall</b>	Food stall operating in Government schools excluding pre-tertiary and tertiary institutes (i.e. polytechnics, junior colleges, universities). It shall apply for the School Canteen Stall sub-scheme under the Eating Establishment scheme.
<b>Sub-scheme</b>	Refers to the type of Eating Establishment scheme, depending on the nature of business of the company / establishment. For example, a food stall in a food court or wet market shall apply for the Hawker sub-scheme under the Eating Establishment scheme.
<b>Virtual brand</b>	Refers to a "brand" of eating establishment (EE) or food preparation area (FPA) that does not have a physical (brick and mortar) shop bearing a signage with the said branding.
<b>Working day</b>	Refers to any day except Saturday, Sunday and Public Holiday.

## ANNEX D – SPECIFICATION OF THE MUIS HALAL CERTIFICATION MARK

The Muis Halal certification mark used for display shall be subject to the following specifications:

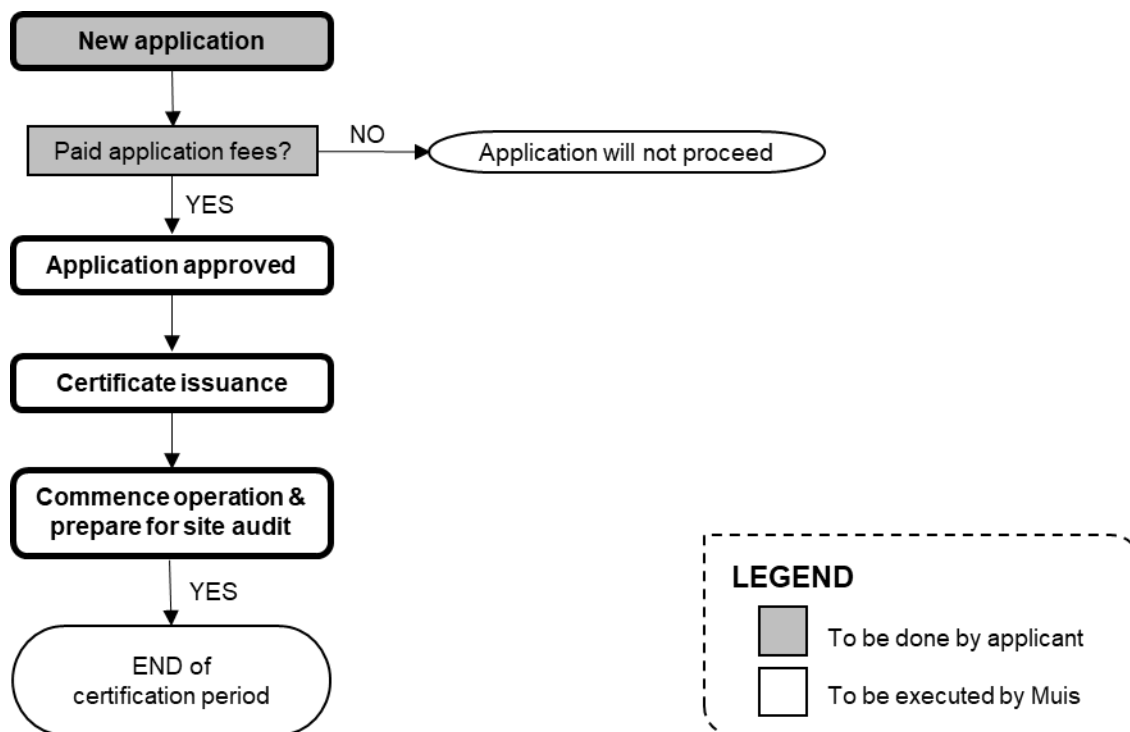
- 1 The Halal certification mark shall always be used in its original proportions and may be proportionately resized;
- 2 The resolution of the mark shall be sufficient such that the wordings on the mark is readable;
- 3 The mark shall be reproduced in its official colours as shown below or in black and white.
- 4 The Halal certification mark shall not be bigger and made more prominent than the company's branding.



- 5 The Muis Halal Certification Mark shall:
  - a) be used only during the validity of the Muis Halal certificate;
  - b) be used only for premises covered by certification;
  - c) be placed in a location that will not be deemed as disrespectful;
  - d) not be used in a manner that may result in misinterpretation on the scope of certification;
  - e) not be visible on any materials associated with the establishment, including signages and collaterals, if not certified by Muis to prevent any false and misleading advertising of Halal Certification.

Any failure to comply with the above conditions regarding the display of the Muis Halal Certification Mark will be considered as misuse of the mark. Such misuse may be deemed an offence under the Administration of Muslim Law Act (AMLA).

## ANNEX E – SHORT TERM SUB-SCHEME



Applicant for Short Term sub-scheme shall be subject to the above process flow during processing of their application:

1. Pursuant to Clause 2.5, the application shall be submitted at least 5 working days before commencement of operations;
2. Pursuant to Clause 8.1, Halal certificate shall be issued upon payment of certification fees;
3. The certificate holder shall commence operation of the stall upon collection of the Halal certificate;
4. The certificate holder shall prepare for site audit by Muis.
