2024 MOE KINDERGARTEN REGISTRATION EXERCISE **Online Registration for MK Sibling Priority Admission (Priority Order 2)**

Singapore Citizen (SC) and Permanent Resident (PR) children born between 2 January 2020 and 1 January 2021 (both dates inclusive), who have elder siblings currently studying in K1 - P6 in the MK or the primary school that the MK is located within, are eligible for sibling priority (Priority Order 2) admission to 2025 K1.

If you intend to register your child under sibling priority admission, you will need to submit your application online during the 2024 MK registration period.

MK Registration Period

From 9am on Friday, 16 February 2024 to 4pm on Tuesday, 20 February 2024

You will be notified of the Open Admissions (OA) registration outcome by **Monday, 15 April 2024 via e-mail**. If you do not receive the outcome e-mail, you should check the junk e-mail folder. Otherwise, you can contact the MOE Kindergarten (MK) directly.

If you need assistance for your child's application, you can refer to the OA online registration guide (www.moe.gov.sg/mk-howtoregister), or contact your preferred MK directly (www.moe.gov.sg/schoolfinder-mk). For more information on MK matters, you can visit the MK website (www.moe.gov.sg/mk).

If your child is currently enrolled in an Early Years Centre (EYC)¹ partnering an MK, you will also receive a notification letter for EYC children by 31 January 2024. You will be directed to the same registration webpage via the QR code / URL link above to start the registration process.

- More information on EYC registration, including the list of EYCs and their partner MKs can be found on the MK website (www.moe.gov.sg/mk-howtoregister).
- Should you choose not to register your child via EYC admissions for a guaranteed K1 place at the partner MK, or subsequently choose not to accept your child's guaranteed K1 place at the partner MK, your child's K1 place in the partner MK will be forfeited. If you wish to register your child at a non-partner MK, you should register using the OA registration form. Your application will be considered under the MK OA registration and subject to the same conditions as all other OA applications.
- You can only register your child at one MK. Multiple applications will not be accepted. If you need to amend your submitted registration details or wish to register your child for a different MK, you can submit a new application. If you have submitted multiple applications, including applications in both EYC and OA registration, **we will only consider the latest application received within the stipulated MK registration period.**
