


ClickChat is the newest application for photo-sharing. You and your friends decide to make an account.

## You picked "Just Once"!

## Great, you've made the right choice!

Clickchat will not be able to to track your movement constantly. This protects your location data, which helps keep your personal information safe.

# This data trail that we leave behind is what we call a 'digital footprint'.

- When we allow Clickchat to collect our location data just once, we are aware of what information is being collected.
- This is what we call an active digital footprint, which is the data that users consciously leave behind on the Internet.

## You picked "Always"!

### That wasn't the best choice!

Clickchat is now able to track your movement constantly, which means that your location data is free to access by the app. This could put your online and offline identities in danger.

# This data trail that we leave behind is what we call a 'digital footprint'.

- Allowing Clickchat to always collect your location data means that your movement will be tracked even if you are not using the app.
- This is what we call a <u>passive digital</u> <u>footprint</u>, which is the data left behind without the user's knowledge.

### **Definition**

The digital footprint you leave behind makes up your **online identity**.



### **Online Identity**

A compilation of all the data about you that exists online

Your online identity is not just the user name and image that you use in your profile but can include other things as well, such as:

- Videos you've watched on a streaming platform
- Your browsing history
- When and where you use certain apps



# You might ask, "Why is your data being collected?"

- → Companies and online platforms often collect user data to personalise the services they provide and use it for targeted advertising.
- → For example, TikTok creates a "For You" page by analysing the footprint of all the videos you've watched on the platform.
- This is done with the intention of creating a better experience online, as users are shown content that is tailored to their likes and preferences.
